



# **Spring-summer community events outreach summary**

10/1/14

## **Purpose and overview**

Community events held in spring and summer 2014 provided Puget Sound Energy the opportunity to engage and inform Eastside residents about Energize Eastside through relaxed, informal settings. The purpose of this outreach was to provide the public with current information about the project, potential route segments, public involvement, the advisory group process, and narrowed route options. The events also provided opportunities for the public to provide feedback and learn how to get involved with the project.

#### **Format**

An Energize Eastside information table with project hand outs, maps, visual aids, and comment cards was set up at each event. Whenever possible, this table included or was adjacent to a table with information on PSE's conservation and energy efficiency programs. Project team members were available to share information and answer questions about the project.

## **Events and community interactions**

Project team staff attended ten events, engaging a total of 1,200 community members. Thirteen visitors submitted written comments about Energize Eastside during the events. Below is a table summarizing attendance and comments received at these events.

# Themes heard during the events

Many table visitors were unfamiliar with the project and were therefore interested in general project information. These visitors were appreciative of the information provided and the outreach work. Below are themes heard during the 10 events.

Note: This section reflects a synthesis of individual conversations, questions, comments and themes that were raised during the events. The synthesis provided is not intended for use as a verbatim transcription. Attendees were encouraged to provide comments on hard-copy comment cards or through the project website. Written questions and comments are summarized in the monthly comment reports and responded to when necessary.

- Informed about Energize Eastside through local homeowners associations
- Concerns about Segment M and pipeline safety
- Concerns about building along Lake Washington
- Preference for using the existing corridor
- Questions about design structures and locations
- Questions about the need for the project

- Questions about undergrounding and the effect on reliability during storms
- Questions about the Seattle City Light corridor
- Questions about electromagnetic fields (EMF) from the lines
- Questions about power reliability
- Interest in strengthening existing power grid
- Support for the need of the project
- Concerns about property value impacts
- Question about noise from transmission lines
- Questions about PSE's energy generation portfolio
- Question about the impact of power lines to wildlife
- Question about how this project relates to the Sound Transit expansion on the Eastside
- Concern that PSE is committing too much time and resources to public outreach
- Concern that wealthier neighborhoods will have more of a voice in the project

PSE appreciates input and expression of interests and concerns. Input from the community helps PSE with the route selection process as the project moves forward.
